SHAREHOLDERS WITH REGISTERED SHARES FNAC DARTY

The FNAC DARTY group is committed to protecting personal data. It ensures the highest level of protection for your personal data in compliance with data protection regulations.

This personal data policy informs you about the processing of personal data related to your registered FNAC DARTY securities account, as well as your use of the VoteAG portal, should you choose to use this tool.

1. Identity of Data Controllers

FNAC DARTY has entrusted the management of registered share accounts to **UPTEVIA**, which acts as the manager of shareholder data and publisher of the VoteAG platform.

2. Purpose – Use of Your Data

Management of Your FNAC DARTY Registered Securities Account

Your personal data is necessary for the management of your FNAC DARTY registered securities account, including tasks such as invitations to general meetings, dividend payments for registered shareholders, etc.

You can access this account through the VoteAG platform, which is a single access portal provided by UPTEVIA on behalf of FNAC DARTY. If you have chosen to use the VoteAG platform, your personal data will be processed for managing your user account and offering you the services of this platform.

3. Legal Basis for Processing

The processing of your data related to the purposes outlined above is based on a legal obligation that we must comply with.

- **For pure registered shareholders:** We also process your data as part of the account agreement you returned to us when you registered as a registered shareholder, as it is essential for providing you with the specific services offered to registered shareholders.
- **For administered registered shareholders:** We also use the personal data about you that has been provided by your bank if you are an administered registered shareholder.

Users of the VoteAG platform:

The processing of your personal data collected via the VoteAG platform is based on your acceptance of the terms and UPTEVIA's conditions of use and your consent to the processing of personal data for the purposes mentioned above.

4. Categories of Data and Source of Processed Data

The personal data about you includes:

For the management of your FNAC DARTY registered securities account:
Identification data, personal contact details (address, phone number, email, date and place of birth), bank account details, family situation, and economic information (only for exemptions from withholding taxes). We do not directly collect sensitive personal data about you, but we may receive, in very specific cases, information related to your health status in the context of legal protection measures for individuals (guardianship, curatorship, etc.).

For access via the VoteAG platform:

IP address, cookies strictly necessary for providing the service.

Source of Processed Data :

- The data you provided to us during your registration as a registered shareholder.
- If you use the VoteAG platform, the data you provided when creating or modifying your VoteAG account, as well as the technical data related to your use of the platform (IP address, cookies, etc.)
- The data transmitted by your bank;
- The data related to the purposes mentioned above that you provide to us at any other time.

5. Recipients of Personal Data

The collected data is intended for the authorized services of FNAC DARTY, as well as UPTÉVIA.

We may also engage service providers in the organization and conduct of the general meeting for the exercise of voting rights and their accounting.

We transmit certain of your personal data, strictly necessary, to the following categories of recipients:

- The French Tax Administration as part of our legal obligations;
- Your bank for any transfer of shares and within the framework of the legal requirements for reconciling shareholder files for administered registered shares (Articles L 225-16 and R225-90 of the French Commercial Code);

We may also be required to transmit your data in certain specific cases to the following persons, including:

- Notaries (donations, inheritances, divorce) and bailiffs;
- Legal protection measures for individuals: to the person or persons designated in this context (guardianship, curatorship, etc.);
- To shareholders requesting it at our headquarters, as part of our legal obligations, the information about you contained in the shareholder list, which includes the name, usual first name, and address of each holder of registered shares;
- Authorized organizations in accordance with the law.

6. Retention periods

The data related to your FNAC DARTY registered securities account is retained in accordance with the applicable regulations regarding the retention of books and documents, as well as the standards set by the FBF and CFONB.

Personal data related to VoteAG accounts is retained until the accounts are deactivated. This deactivation may occur at the request of the person for whom the VoteAG account was opened. VoteAG accounts are deactivated upon termination or expiration of the contract.

7. Your Rights Under Data Protection Regulations

You may exercise your rights (access, rectification, erasure, objection, deletion, restriction, and portability where applicable, as well as define the handling of your personal data post mortem) by email or by post:
